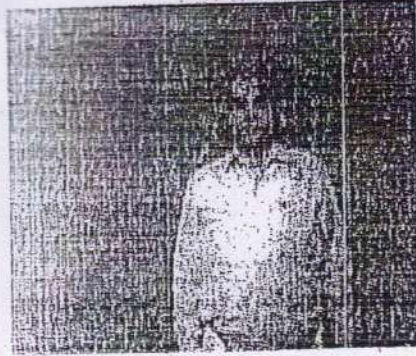

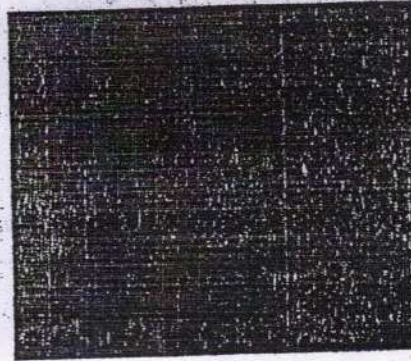

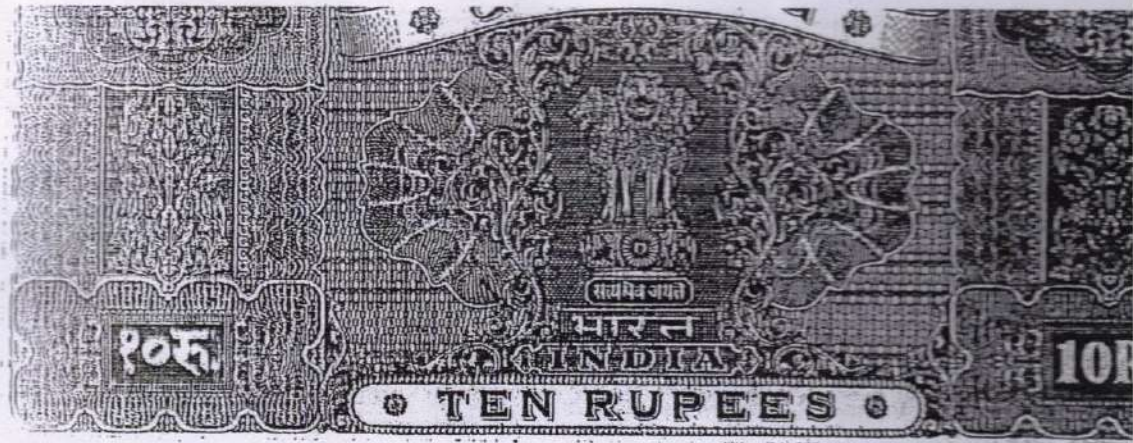

**TRUST DEED
OF
DAYAWATI MODI PUBLIC SCHOOL TRUST**





Whereas the Settler is desirous of establishing a trust for public charitable objects.
