





Whereas the Settlor is the founder/creator of the Dayawati Modi Public School Trust and this trust is in existence/has been functioning since 14th April, 1998.







hereinafter jointly referred to as "trustees" (which expression shall, unless excluded by or repugnant to the context, be deemed to include the trustee or trustees for the time being of these present and there successors in office) of the other part.
